<p><b>Notify the Social Security Administration (SSA)</b></p> <p>In order to receive Social Security benefits or to check to see what the beneficiary is entitled to, contact the Social Security Administration. <p><b>Notify the Three Credit Bureaus</b></p> <p>Contact all three credit bureaus to ensure that no one will be able to open new credit using the decedent's information.
